Union members and their children may now apply for the college scholarships awarded by the Local 342 Safety, Education, Cultural & Activities (SEC) Fund.

The number of scholarships awarded depends on the number of students applying for aid. Generally, the Fund awards scholarships in various amounts from \$10,000 to \$3,000. The awards are based upon need and are subject to change, and are also based on total scholarship money available in any given year.

Who is eligible: Local 342 Union members and their dependents who **will graduate from High School June of this year (2023)** whose employer makes contributions to the Local 342 SEC Fund. Eligibility is based on employment with a contributing employer for one (1) year or more dating backwards from August in year scholarship is given.
