Artificial Intelligence (AI) is creeping ever too quickly into our lives and while I do not believe it is something we could or even should stop entirely, I do know it is something that requires regulation and guidance. This is why we recently started adding AI job protection language in all of our contract proposals. When AI is used to improve the safety and efficiency of our work, it is less of a concern. I am not saying this to scare you, but rather to inform you of its importance. So when we negotiate your next contract, understand, it is something we may need to strike over. It is that important! If we address AI now, before it hits our industry, we will be better off in the end.

This year we were successful in gaining much needed AI protection language in the contract with one of our largest employers; Stop & Shop. It did not come easy, and we did have to strike to achieve it. Oftentimes, when the dust settles and the contract is signed, the strike itself is almost forgotten in the minds of most, but AI job protection lives on forever in our contract. We had an amazing negotiating committee in Stop & Shop, and we would not have been successful without their perseverance and strength.

I say this to you because each and every one of you can be just as successful. We are Local 342 and if we set our minds to do something, we get it done! Don't you ever forget that!!

In 2023, organized labor took a stand making its presence felt across the nation with strikes, rallies, protests, unprecedented contract gains, and landmark organizing campaigns. Collectively, organized labor took a very vocal and public stand to let those who oppose us and work to undermine us know that we are here to stay. We are stronger than we have been in decades with a large percentage of the public supporting us and our agenda related to safety in the workplace, wages on trend with inflation, affordable healthcare, meaningful retirement benefits, and protections against artificial intelligence (AI) technology.

We got workers their jobs back and back pay for their losses. We got together in fellowship, merging our union family with our immediate family to do charitable deeds, enjoy good food, and have fun. Above all, this year served as a reminder that as much as Local 342 members may be different we are the same.

We see each other and relate to each other on a human level. We showed that this fight is bigger than us and that we will use our voices, experience, and strength to preserve the standards of the past while securing the future. NEW YORK PASSES RETAIL WORKER SAFETY ACT!

Local 342 joins sister locals in advocating for the bill to protect workers on the job.

This year, Local 342 staff ventured up to Albany to visit with state lawmakers and advocate for the retail worker safety act.

Secretary-Treasurer Debra Dunn and Local 342 Vice-President and Shop Steward Robert “Bobby” Young made the trip and spoke with several state legislators explaining the issues he and his fellow workers face in the shops.

Unfortunately, the companies have been slow to respond, and stubbornly refuse to take the necessary measures that would protect workers but would also require some financial investment.

Staff from Local 338 and Local 1500 also played a major role in pushing the bill through.

The Retail Worker Safety Act will require employers to provide safety training, and require larger retailers to install panic buttons in their stores.

This bill was sponsored by State Senator Jessica Ramos (D-13) and State Assemblywoman Karines Reyes (D-87).

WORKERS TO STOP AND SHOP: TRY US!

Local 342 Wins Big at the Bargaining Table

Perhaps the biggest challenge faced by Local 342 in 2024 came from Stop and Shop, a subsidiary of Ahold Delhaize. The Local 342 negotiation team and our member led negotiation committee spent the first half of 2024 seeking a new contract with Stop and Shop to address wages, annuity payments, and the use of AI in our stores.

These negotiations became even more critical after news broke of upcoming store closures.

Stop and Shop management refused to reach a fair and equitable deal and continued to drag their feet at the bargaining table. After unending slights and disrespect, our members finally said enough is enough! On June 21st our members voted unanimously to authorize a strike against Stop and Shop.

"We just need to show them that we mean business and we're not gonna stand for their nonsense!" said negotiations committee member Terri Candela.

Despite this, the company's head remained firmly pitted in the sand (and their ass). They continued to slow walk negotiations and called the strike vote "standard." Clearly the company needed a wake up call.

On June 28th members rallied outside of the Carle Place Stop and Shop near the site of the ongoing negotiations.

Finally, on July 2nd, our brave and bold union siblings walked off the job in the Hamptons telling Stop and Shop firmly, reach a deal now or face the consequences. Try us!

Not long after, the union reached a tentative agreement with the company, which included increased 401(k) contributions, AI language, and industry leading wage increases. Additionally, the union secured the jobs of all Local 342 members, ensuring that no one would be laid off in the upcoming store closings.



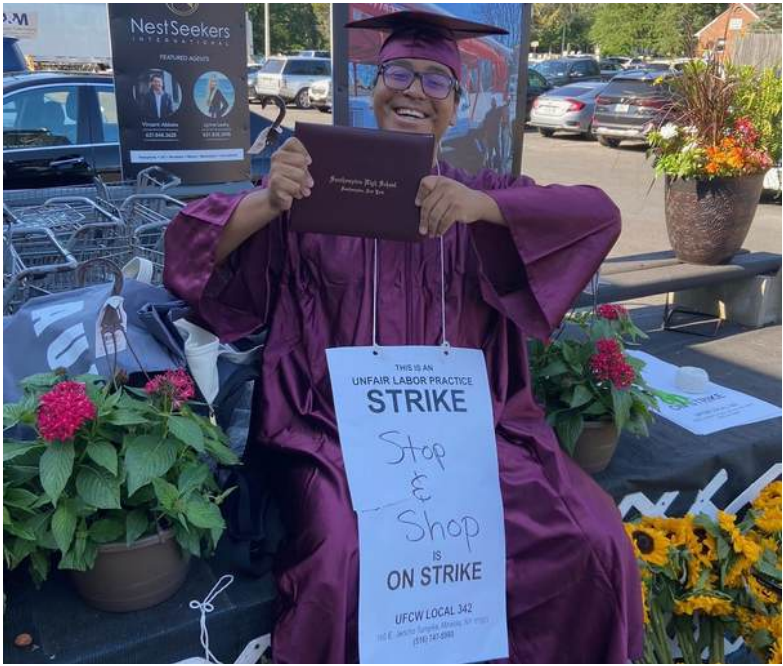

Local 342's safety department faced down numerous threats to our members' well being throughout 2024. At Railex, management had members grinding off paint without providing necessary personal protective equipment like masks and appropriate ventilation. Breathing in particles of dried paint is particularly dangerous to the lungs and eyes.

The dangerous conduct of the employer put not only the members who were grinding at risk, but also other members in the shop who were exposed to the air particles.

Local 342's safety department stepped up and forced the employer to give protective goggles, masks and gloves to members in the shop.

The tireless work of Local 342's safety department keeps our shops safe and holds employers accountable when they fail to protect our members from safety risks. In 2024 the department sought to take safety 101 directly to our members.

In Bogopa, members were given a course in safety training to ensure that all our members are prepared to identify and eliminate safety risks as they come up.

Local 342 is proud to receive these awards, and thanks the Boy Scouts of America and the UFCW Minority Coalition for these great honors.

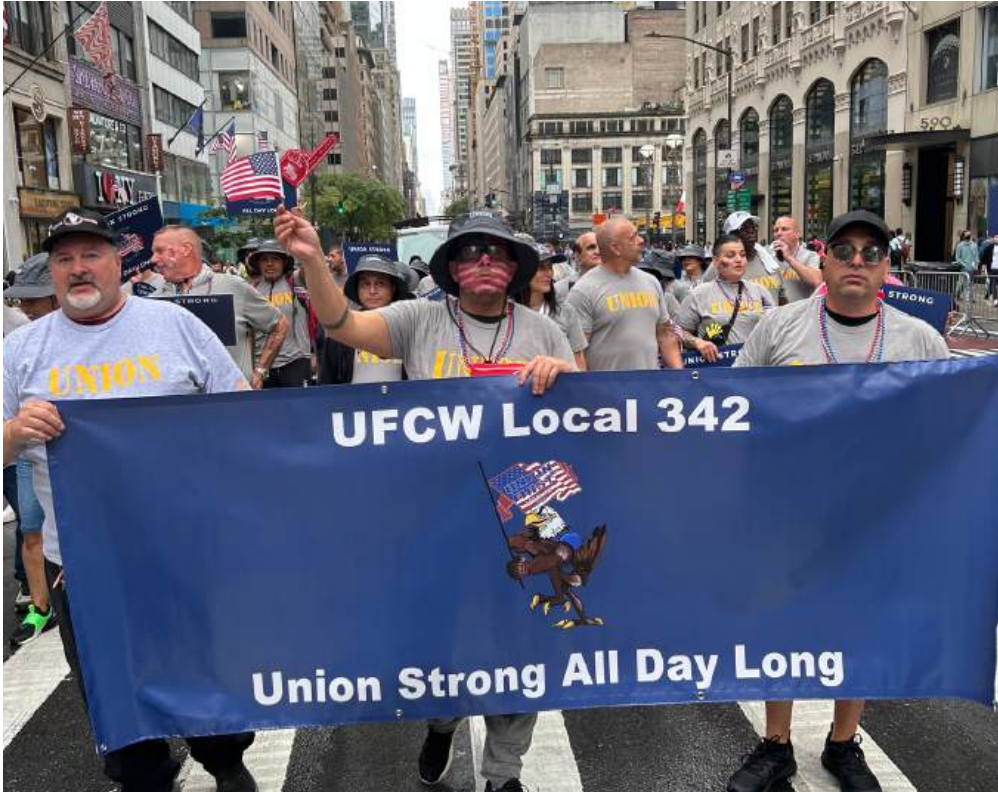
LABOR DAY 2024

STRIDES AGAINST BREAST CANCER

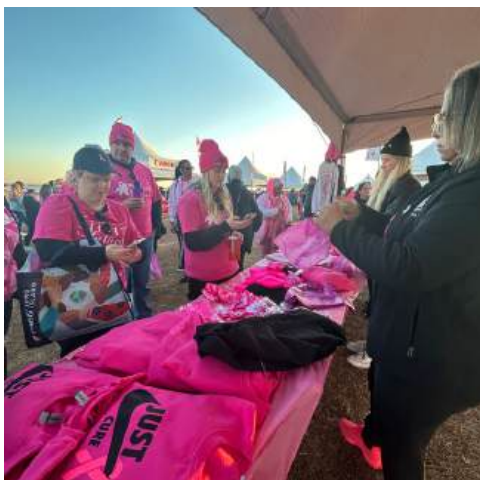
Perhaps the crown jewel of Local 342's yearly charity drives is our participation in the American Cancer Society's Making Strides Against Breast Cancer events throughout October.

MESSAGE FROM THE LEGAL FUND

BROUGHT TO YOU BY SIMON AND MILNER

TAKE ALL STEPS TO AVOID A DEFAULT JUDGMENT

Even if you believe you were not properly served, do not ignore a summons naming you as a defendant. If you do not believe you were served properly or you do not believe the claim against you is valid, those would be affirmative defenses to raise in your answer.

If you think the claim being made against you is a valid claim, that is still not a reason to ignore the paperwork. There are several negotiation options which may save you money and stop interest from accruing. If you simply ignore the paperwork, you will get a default judgment against you. A judgment could include costs incurred by the creditor including attorney fees and will continue to accrue statutory interest until fully satisfied.

Once a default judgment is entered against you, the creditor can take steps to enforce the judgment. These steps can include freezing your bank account, garnishing your wages, and placing a lien on your real estate. The court can direct that other property such as brokerage accounts, rents due to you, your automobile, and other personal property be utilized to satisfy the judgment. It is then up to you to petition the court for leave to stop the collection process and vacate the judgment; however you must have a valid reason for your default for the court to consider vacating same.

A default judgment being filed against you can negatively impact your credit score, your insurance premiums, your interest rates on future purchases, the interest rate on your credit cards, the interest rate on future mortgages, among other things. Do not wait. As soon as you learn of a lawsuit against you, you should contact an attorney to protect your rights.

In most cases you only have 20 days to respond.

IS A TRANSFER ON DEATH DEED RIGHT FOR YOU?

New York State has recently added a new section to the New York Real Property Law allowing Transfer on Death Deeds (TODD). The Transfer on Death Law allows transferor to designate a beneficiary to inherit the transferor's real property automatically upon the death of the transferor without the need to probate or administer the estate.

The TODD must be recorded during the lifetime of the transferor in the county in which the property is located. Thus the Transfer on Death Deed becomes a public record. The Transfer on Death Deed is revocable by transferor during the lifetime of the transferor. In the event the designated beneficiary dies prior to the Transferor, then the designation will lapse upon the death of the beneficiary. If there is more than one designated beneficiary, upon the death of one designated beneficiary, the interest in the predeceased beneficiary will revert to the then living named beneficiaries in equal interests.

A designated beneficiary's interest in a TODD does not pass to his/her heirs. In the event the sole designated beneficiary predeceases the transferor, the TODD shall be deemed null, void and of no further effect, resulting in the property remaining an asset of the transferor/owner to be distributed in his/her estate proceeding.

TODD to multiple beneficiaries cannot be used to Transfer unequal shares. The transferor retains title to the property and is free to use, sell, mortgage, rent, lease or otherwise encumber the property at all times prior to the transferor/owner's death. A TODD will not protect the transferor/owner against creditors and upon death, the designated beneficiary takes title subject to mortgages and liens. The designated beneficiary's creditor cannot attach to the property until the Transfer upon death is completed.

This type of Deed is not best for everyone. If you are interested in a TODD call our office to determine if it is right for your circumstances.
