Plan participants and their eligible dependents may now apply for the scholarships awarded by the Local 342 Safety, Education, Cultural & Activities (SECA) Fund. The number of scholarships awarded depends on the number of students applying in any given year.

Generally, on an annual basis, the Fund awards scholarships in various amounts up to \$10,000 based on total scholarship money available in any given year. The awards are made based on academic merit criteria (for example, academic grade point average, SAT/ACT score, extra-curricular activities, recommendations, scholarship, other recognition of achievement, etc.)

Who is eligible?

Plan participants and their eligible dependents who will be entering their first (freshmen) year during the time period of July 1, 2026 – June 30, 2027 at (i) an institution of higher learning (such as a college, university or other school) accredited by an Institutional Accrediting Agency recognized by the United States Department of Education; or (ii) a vocational and/or technical school that is accredited by an Institutional Accrediting Agency recognized by the United States Department of Education. Eligibility is based on employment with a contributing employer for a continuous period of one (1) year or more dating backwards from August 2026.

- c. Any other standardized test and/or subject specific competency exam that you have completed and want to be considered
- d. Letters of Recommendation (Maximum of 5).
- e. If you are not the member, proof that you are a dependent
 - i. Are you a child of the member? Submit a Birth Certificate (or adoption records, if applicable).
 - ii. Are you the spouse of the member? Submit your Marriage Certificate
 - iii. Are you the domestic partner of the member? The Fund will follow up for additional proof.
